CAVITEX toll rate adjustment to be implement<u>ed</u>

TRECE MARTIRES CITY, Cavite (PIA)-- The Toll Regulatory Board (TRB) approved the new toll rates for CAVITEX R-1 on May 22, 2022; motorists plying through CAVITEX R-1 segment (Cavitex Longos Bacoor to MIA Exit v.v.) will be charged the following VAT-Inclusive amounts of Php 33.00 for Class 1 vehicles, Php 67.00 for Class 2, and Php 100.00 for Class 3 respectively.

The toll rates adjustment to be applied by Cavitex Infrastructure (in Parañaque Toll Plaza)) and its joint venture partner, Philippine Reclamation Authority (PRA) was being deferred last May 12 to provide more time for the registration of PUV drivers and



PhilHealth holds series of meetings with stakeholders on UHC implementation

The Philippine Health Insurance Corporation (PhilHealth) recently staged a series of virtual meetings with their various stakeholders in order to keep them abreast on latest developments on the implementation of Republic Act 11223, otherwise known as the Universal Health Care Law.

Around 1,200 participants from different sectors comprising of employers and business owners, labor and overseas contract worker groups, recruitment and manning agencies, health care professionals and medical societies, and media practitioners have attended the half-day sessions organized by the state health insurer.

Local Chief Executives (LCEs) of partner Local Government Units (LGUs), human resource officers of National Government Agencies (NGAs) and administrators of various organized groups whose members consist of self-earning individuals such as small traders and job order contractors also graced the event.

The meetings were designed to refresh them on the salient points of the UHC Law and how it aims to provide Filipinos with financial risk protection as they gain access to quality and affordable healthcare services. Highlight of the presentations include the benefit packages introduced as part of PhilHealth's COVID response in the last two years from testing, home and facility-based isolation, hospitalization, to vaccine injury compensation.

The participants were also briefed on the packages that will either be expanded or introduced in the immediate future such as additional dialysis sessions, an outpatient mental health package, and continuing full financial risk protection

As mandated by law, PhilHealth introduced and is now vigorously enlisting facilities so that members and their dependents can avail themselves of primary care benefits that include regular consultations, preventive and promotive care, select diagnostic tests and medicines upon the recommendation of the primary care professional.

To be able to enhance and sustain existing benefits, and introduce new packages to meet patient demands, the attendees representing major stakeholder groups were informed and thoroughly briefed on membership and contribution issues, particularly on the resumption of the scheduled premium contribution as mandated by the UHC Law.

According to Section 10, contribution rate and ceiling for Direct Contributors for 2022 shall be at 4 percent and P80,000, respectively. The Agency said it will resume collecting the legislated contribution schedule effective January 2022. However, its collection systems particularly the Electronic Payment and Reporting System (EPRS) and the PhilHealth Member Portal will be ready for payments/remittances following the adjusted rate starting the month of June 2022, while payment of the one percent differential for the paid periods (referring to January to May 2022) may be settled until December this

Cognizant of the situation of many Filipinos at this time of the pandemic, PhilHealth deferred implementation and instead supported efforts in Congress for a possible legislation that would grant the President with powers to suspend increases during national emergencies.

However, with no legislation yet in sight, it said it is resuming implementation of the contribution schedule this year

Overall, the fora received positive response from the stakeholders where most of the participants expressed readiness to support its programs and policies in order to sustain their benefits. They also manifested willingness to become social

Methanol detection kit project likely completed by August

MANILA - The field test kit to detect methanol contamination in lambanog is expected to be completed by August, an official of the Department of Science and Technology in Calabarzon (DOST 4-A) said Mon-

"We target the field testing to be completed by intellectual property protection, then work for its commercialization. Our plan for the region is for the local producers of lambanog to benefit from the production while we are waiting for technology adopters," DOST 4-A Director Emelita Bagsit told the Philippine News

Bagsit said to date, there is no specific instru- (FDA) issued an advisory

ment that the local distillers could use to trace or detect contamination in methanol.

"They rely on a traditional method wherein they discard the first drops of lambanog since the first few milliliters of lambanog in the distillation process are high in methanol content. Aside from that, they are not using other instruments for quality assurance purposes," she

Local distillers, she said, do not have access to instruments to test or determine the methanol level of their products before they reach the market.

"Only those lambanog brands that have LTO (license to operate) and Certificate of Product Registration have the product testing, but this is not yet included in the requirements for business registration," Bagsit added.

In 2019, the Food and Drug Administration about mass hospitalization "allegedly due to drinking distilled coconut sap, locally known as lambanog."

"Based on available data (Philippine Coconuts Authority 2019), there were only 14 (lambanog producers) that have a certificate of product registration from the FDA. That means there are more fly-by night operations, making it more dangerous to have a high level or permissible content of methanol (in lambanog)," Bagsit said.

She said there may be existing kits, but these are imported and quite unaffordable from the micro to small businesses.

"The average person goes to local sellers for lambanog. More than just an innovation, this methanol detection kit project is a solutions-driven project that aims to address issues like lambanog poisoning," Bagsit

DTI warns establishments that price tag is a must

over booming e-commerce transactions in the country, the Department of Trade and Industry (DTI) warns business owners and establishments to disclose prices in compliance with the Fair Trade

The DTI Consumer Protection Group (DTI-CPG) urges online and physical store owners to comply with:

Article 81 of the Republic Act No. 7394 or the Consumer Act of the Philippines which requires appropriate tags, labels, or markings that indicate the prices of consumer products sold in retail. With these, products must not be sold at higher prices than stated; and with Section 5 of Republic Act No.

7581 or the Price Act that stipulates that selling a basic necessity or prime commodity without a price tag is prima facie evidence of profiteering.

To strengthen the implementation of the Price Act and Consumer Act, the DTI, Department of

Agriculture (DAR), Department of Health (DOH), Department of Environment and Natural Resources (DENR), Intellectual Property Office (IPO), and National Privacy Commission (NPC) have recently issued the Joint Administrative Order (JAO) No. 22-01, consolidating all existing rules and guidelines on online businesses.

The provisions of JAO No. 22-01 reiterate laws that apply to the establishments' responsibility to comply with the requirements of price tags on products and services of physical and online stores.

"We are firm in enforcing these laws, especially on the requirement of price tags, to ensure consumers' right to choose quality products at reasonable prices," says DTI - Consumer Protection Group (CPG) Undersecretary Atty. Ruth B. Castelo.


