PBBM: Unilever's P4.7-B Cavite plan to create more jobs Pres. Ferdimand R. Marcos Jr

GENERAL TRIAS, Cavite (PIA) -- President Ferdinand R. Marcos Jr. led on Friday the inauguration of Unilever's P4.7 billion-personal care facility in General Trias, Cavite, which he said was a result of his trip to Belgium.

The President said the state-of-the-art-facility is one of the results of his trip to Belgium during the Association of Southeast Asian Nations (ASEAN)-European Union (EU) Summit in

December last year.

"I would like to note that this major investment is amongst the pledges that we received during our trip to Belgium for the ASE-AN-EU Summit last December," President Marcos said in his speech during the inauguration of Unilever's New Beauty, Well-Being, and Personal Care Factory (BWPC).

The President is hopeful that Unilever's largest personal care facility in the world will generate over 5,000 direct and indirect employment opportunities for the people.

"It is a truly weldevelopment come for all our shared efforts to strengthen our manufacturing sector and to ultimately create jobs and gainful opportunities for our people. This manufacturing plant is projected to produce nearly 90,000 tons of various personal care products annually. And this is to meet the export Turn to page5



Lowering the optional retirement age of government workers

Sen. Ramon Bong Revilla Jr., chairperson of the Committee on Civil Service, Government Reorganization and Professional Regulation, sponsors Senate Bill No. (SBN) 2444 under Committee Report No. 134, or an Act Lowering the Optional Retirement Age of Government Workers from Sixty (60) Years to Fifty-Six (56) Years.

Wednes-During day's plenary session September 20, 2023, Revilla said the measure is in response to the clamor coming from civil servants who, if given the option, would wish to enjoy their retirement days at a much earlier time.

The sanator said the committee tried to balance the capability of the Government Service Insurance System (GSIS) on one side, and the right of its member to have an option to retire earlier on the other side.







Rabies cases decrease by 8% from Jan. 1- Sept. 2

MANILA - The Philippines has recorded an 8 percent decrease in rabies cases, from 282 down to 259 from Jan. 1 to Sept. 2, compared to the same period last year, the Department of Health (DOH) reported Thursday.

However, citing latest data, the agency said cases have shown a continuous increase, reporting 29 new cases in the recent four weeks.

Cases increased in the National Capital Region, Ilocos Region, Central Luzon, Region 4-B (Mimaropa), Bicol Region, Central Visayas, Eastern Visayas, Zamboanga Pennsula, Soccsksargen and Caraga "in the recent three to four weeks and/or one to two weeks".

In the past four weeks, one to three new cases have been reported.

"Proper wound management is important when dealing with animal bites. Likewise, immunization is critical to prevent rabies infection," the DOH said, noting that there are two types of immunization given to animal bites, depending on the severity and site of the animal bite.

Rabies vaccines are given if a person gets minor, superficial scratches, or abrasions without bleeding, including those induced to bleed below the neck.

Meanwhile, rabies vaccines and rabies immuno globulin are given if a person has puncture wounds, lacerations, avulsions or scratches, abrasions with spontaneous bleeding, or scratches and abrasions located in the neck and head.

"Generally, from zero up to 10 days of bite from a rabid animal, a person may experience non-specific manifestations, such as fever, sore throat, anorexia, nausea, vomiting, generalized body malaise, headache and abdominal pain," the DOH said.

"Afterwhich, manifestations such as hyperactivity, hypersalivation, disorientation and hallucination, bizarre behavior, seizures, nuchal rigidity or paralysis appear."

The public, especially those who have been bitten, is advised to immediately seek medical attention through animal bite centers in communities.

Pet owners are also reminded to be responsible by looking after their pets and having them vaccinated. source: (PNA)



to cybercrime response
team in Calabarzon

CALAMBA CITY (PIA) – The Philippine National Police's Regional Anti-Cybercrime Unit (PNP-RA-CU) in Calabarzon said more victims of online scams have been filing complaints since the creation of cybercrime response teams in the provinces.

Police Major Rainier Sison Julio, assistant chief PNP Calabarzon's RACU, said complainants have been reporting cybercrime incidents since the creation of the Provincial Anti-Cybercrime Response Teams (PACRT) in Cavite, Laguna and Rizal.

"Many victims are

now reporting cybercrimes in the region since we operationalized the PACRT," he

said. From January 1 to August 31, 2023, RACU IV-A recorded a total of 3,384 cybercrime cases where online swindling or estafa accounted for the highest number of cases, with 2,151 reported incidents.

Online swindling or estafa is a cybercrime that involves fraud, deception, or misrepresentation to cause financial harm or other damage.

Data interference and illegal access of data were the second and third most reported cybercrimes, with 306 and 255 incidents respectively.

Among the provinces, Cavite logged the highest number of cyber-related incidents, with 1,815 cases while Quezon had the lowest number of cybercrimes.

Julio noted that the absence of PACRT in Quezon and Batangas may explain the lower number of cybercrime incidents in those provinces compared to Cavite. Plans are underway for the creation of PACRT in Batangas and Quezon.

He urged the public to promptly report any cybercrime incidents even as **Turn to page 7**
