# **DENGUE FEVER - What is dengue???**

☐ Dengue that spreads from mosquitoes is a viral infection. Through the bite of the female Aedes mosquito, the microbes which cause various complications are transmitted or transferred to humans. If not taken on time, complication will worsen. Yet, early diagnosis and timely treatment can save lives.

☐ Symptoms of Dengue:

The person suffering from this disease may have no symptoms at first and only appear when it becomes severe. Occasionally, its symptoms can cause confusion for other illnesses or viral infections such as flu or flu. But, its first symptoms often start four to seven days after a mosquito bite and usually last three to ten days. Its first symptoms are high fever recurring every four to six hours. There is no cause of any infection such as painful urine or UTI, colds, and cough or phlegm discharge. The fever can last up to seven days. The severe symptoms of severe dengue are as follows:

- □□Severe headache
- ☐ Pain around the eyes
- ☐ Having rashes
- ☐Gum and nose bleeding
- □Extreme abdominal pain or abdominal pain
- □ Vomiting
- □Days in quarantine:

From 3 - 14 days, usually 4 - 7 days

☐ Method of spreading:

Dengue flu was infected to humans through the bites of infected female mosquitoes Aedes. If a patient suffering from dengue flu is bitten by a vector mosquito, the mosquito becomes infected and it spreads the disease by biting other people. Illness does not directly spread from person to person.

☐ What to do when there is dengue???

This disease has no cure or cure. There is only medicine available to relieve fever or sick feeling and fight the diseases caused by it. For high fever, taking paracetamol can help. Besides, it is important to drink plenty of water and rest well. Experts remind to avoid giving nonsteroidal anti-inflammatory drugs such as ibuprofen and mefenamic acid.
