

POE BATS FOR TAX INCENTIVES FOR DOCTORS PROVIDING FREE SERVICES

Doctors who brave the frontlines - with or without the pandemic - to give their services for free to where healthcare needs are at their direst deserve recognition and incentives, Sen. Grace Poe said.

In her Senate Bill No. 1715 or the Physician Pro Bono Care Act, Poe pitched that physicians rendering free services to indigent patients shall be entitled to a tax credit to be deducted from their gross income.

"A number of doctors have taken it upon themselves to volunteer and render free health services to our people who cannot afford to seek medical attention. The tax incentive is a way of giving back for their selflessness, commitment and expertise," Poe said. According to the measure, the Department of Health (DOH) and the Philippine Medical Association (PMA) are tasked to evaluate the pro bono services rendered by the physicians, considering the number of hours and the nature of treatment involved.

The Bureau of Internal Revenue, in consultation with the DOH and the PMA, will promulgate the rules and regulations for the implementation of the measure.

In pushing for her proposal, Poe underscored the constitutional right of Filipinos to have access to health services, and for the government to endeavor to provide free medical care to the poor. In 2019, the Phil-

PhilHealth mulls releasing 2nd wave of financial support to COVID-19 hospitals

The Philippine Health InsuranceCorporation (PhilHealth) is seriouslyconsidering the release of a second tranche of its Interim Reimbursement Mechanism (IRM) or emergency cashadvance to help hospitals with neededliquidity so that they can respond betterto the increasing COVID-19 patients.policies.

The Agency said it will review each hospital's utilization of the first IRM tranche, and will ask them to start liquidating the said funds to be eligible for the second tranche.

The second wave of IRM funds will be made available to COVID-19 hospitals specifically those in high concentration areas such as the National Capital Region, Regions III, IV and VII where bed capacity either reached full capacity or in critical levels as coronavirus infections increase due to the easing of quarantine policies. However, overall nationwide total COVID-19admissions was only a little over 50% with most admissions in Level 3 or apex referral hospitals. For the second wave of IRM, the state agency said that it will provide concerned hospitals with cash advance equivalent to three months' worth of their claims based on their 2019 claims data.

To date, PhilHealth already released a total of P14.7 billion to 681 hospitals nationwide under its first wave, P7.6 billion or 52% of which went to private institutions. Of this, almost P4.2 billion or 29% was released to NCR, followed by PRO IV-A (Calabarzon) at P1.2 billion or 8%, and PRO III-A (Central Luzon) at P1.1 billion or 7%.

PhilHealth assured the public that its funds are adequate and available to ensure that all patients, whether of COVID-19 or not, adequate care when needed without experiencing financial difficulty as mandated by the Universal Health Care Law.



MAJORITY OF PH TOURISM PLAYERS EXPECT TO BE BACK ON TRACK IN 2021

MANILA – Majority of the tourism players in the Philippines remains optimistic that their businesses will return to normal within six months to over a year.

According to the Philippine Tourism Survey: Covid-19 Edition conducted by Isla Lipana & Co./PwC Philippines (PwC), 63 percent of the tourism players remain optimistic that their businesses will be back on track next year.

The survey also showed that 88 percent of the respondents expect losses of over 50 percent of their 2020 revenues due to the enhanced community quarantine (ECQ) while 97 percent say that coronavirus has the potential for significant impact on their business operations.

The tourism players were asked about the challenges and concerns brought about by the pandemic as well as the ECQ in Luzon and other parts of the country.



tor-to-patient ratio of 1:33,000 - far from the 1:6,600 global average. Worse, six out of 10 Filipinos die without seeing a doctor.

Poe said the COVID-19 pandemic has challenged the country's healthcare system and highlighted the importance of having adequate number of doctors in protecting and advancing public health.

The pandemic also widened the gap to quality healthcare access among the poor and the marginalized.

"Truthful to their oath, doctors reduce or even forgo their fees based on patients' circumstances. But we recognize that they also have a need to sustain their profession and that's where tax incentives could be most helpful," Poe said.

"If doctors could write off their pro bono work on their taxes, we would see more charity care. This is a win-win situation for patients and doctors," she said.

The senator explained that while a favorable tax incentive would result in less tax revenue, generating more free physicians' services could lead to long-term savings for the government's health insurance program, which would offset potential revenue losses.

The Local Disaster Risk Reduction and Management Office distributed free face masks to all the vendors in the public markets for the safety of both the vendors and market goers.

NOVELETA, Cavite (PIA) -- The local government here reported that among the municipalities in the 1st District of the province, it has the lowest COVID-19 confirmed cases recorded with 23 as of July 20, 2020.

On the other hand, neighboring towns of Kawit has 31 cases, Rosario with 32, and Cavite City with 34 cases.

Town Mayor Dino Chua attributed this to the vigorous campaign of each barangay that was fully supported by the local government resulting to majority of the barangays (10 out of 16 barangays) remaining COVID free.

Since the outbreak hit Barangay San Rafael June 24, 2020 with 11 cases recorded, the disease had spread to neighboring barangays of San Juan 1 and San Antonio 1 with 4 cases each, San Juan 2 with 2 cases, and Barangays Salcedo and San Rafael with 1 case each.

Mayor Chua said, "The LGU is determined that they can pass this pandemic with the help of every single citizen of Noveleta."

Out of the 23 COVID patients, six were treated at the Noveleta Med-Care Center, the designated COVID-19 center in the town under Municipal Health Officer Dr. Hilda Bucu.

The quarantine center was commended for its clealiness and comfortable facilities including the good medical care and attention provided by the nursing staff.

Meanwhile, since the start of the community quarantine the LGU continuously provided food packs to the families particularly those greatly affected by the lockdown in Barangay San Rafael III.
