

# SC suspends court operations for Bar exams

MANILA – The Supreme Court on Friday announced the suspension of operations on Sept. 20 in lower courts to give way to this year's Bar examinations.

The suspension covers all first and second level courts in the National Capital Region (NCR) and in all cities where the testing sites for the 2023 Bar examinations are located.

Friday, Court Administrator Raul Villanueva said all officials, personnel, and employees of all courts who will be deployed to the Bar examination sites as Bar personnel are considered to be on official business.

# 'Work, holiday visa' application to Australia to open in 2024

MANILA – The Australian Embassy in Manila said Friday the application for the "work and holiday visa" will open next year as Canberra agreed to include Filipinos in the new visa scheme

The "new reciprocal work and holiday visa for Australians and Filipinos" was announced by Australian Prime Minister Anthony Albanese during his official visit to Manila on Sept. 8 as he and President Ferdinand R. Marcos Jr. sought ways to increase Philippine-Australian economic, cultural, and people-to-people links. According to the Australian Department of Home

Affairs, this type of visa allows eligible nationals aged 18 years to 30 years to have an extended holiday in Australia and do short-term work to help fund their trip; study for up to four months; or do three months of "specified subclass 462" work to become eligible for a second work and holiday visa



## Gatchalian: 4 sa 10 pinoy ang kuntento sa senior high school ayon sa survey

Batay sa resulta ng survey na kinomisyon ni Senador Win Gatchalian at isinagawa noong Hunyo 19 hanggang 23, 2023, 41% lamang sa 1,200 kalahok sa buong bansa ang nagsabing kuntento sila sa senior high school. Mas mataas nang bahagya ang mga hindi naman kuntento o 42% samantalang 16% ang hindi tiyak kung kuntento sila o hindi.

Para kay Gatchalian, sinasalamin ng resulta ng survey ang kabiguan ng programang tuparin ang pangako nitong gawing handa para sa kolehiyo at trabaho ang mga kabataan. Ayon sa isang 2020 discussion paper ng Philippine Institute for Development Studies (PIDS), 20% lamang ng mga graduates ng senior high school ang pumapasok sa labor force, samantalang 70% naman ang nagpapatuloy sa kanilang edukasyon. Lumabas din sa naturang pag-aaral ng PIDS na pagdating sa basic pay, lumalabas na halos walang pinagkaiba ang mga senior high school graduates kung ihahambing sa mga nagtapos ng dalawang taon sa kolehiyo o Grade 10.

Ayon sa survey, mas marami sa Class D (44%) at E (44%) ang hindi kuntento sa senior high school program. Lumalabas naman na 38% at 42% lamang mula sa Class D at E ang kuntento sa senior high school. Sa classes ABC, 57% ang kuntento, samantalang 27% ang hindi

"Nagdagdag tayo ng dalawang taon sa high school pero para sa ating mga magulang, dagdag na gastos lang ang dulot nito. Hindi kuntento ang ating mga kababayan sa senior high school dahil hindi nila makita ang benepisyo ng programang ito," ani Gatchalian, chairperson ng

Sa iba't ibang bahagi ng bansa, magkakaiba ang lebel ng pagiging kuntento o hindi kuntento sa senior high school. Sa Metro Manila may pinakamaraming hindi kuntento, (53%), samantalang 31% lamang ang kuntento sa programa.

Mas marami naman sa Luzon ang kuntento (43%) kaysa sa hindi kuntento (35%) sa senior high school. Sa Visayas, parehong 42% ang kuntento at hindi kuntento sa programa. Sa Mindanao naman, halos kalahati (49%) ng mga kalahok ang hindi kuntento sa senior high school,

Upang tugunan ang mismatch sa skills ng mga graduates ng senior high school at ang mga pangangailangan ng labor market, inihain ni Gatchalian ang Batang Magaling Act (Senate Bill No. 2022). Nais ng panukalang batas na patatagin ang ugnayan sa pagitan ng Department of Education (DepEd), local government units, mga paaralan, at mga katuwang sa industriya.

their compliance with the price ceiling set on rice.

Milo Delos Reyes, Department of Agriculture (DA) Director in Calabarzon, said a monitoring team composed of DA and Department of Trade and Industry (DTI) representatives will conduct daily market monitoring to ensure rice retailers' compliance with Executive Order No. 39.

"We will visit selected public markets in the region every day to monitor the prices of well-milled and regular milled rice," said delos Reyes.

The regional agriculture chief added that the Department of the Interior and Local Government and the National Food Authority would also be part of the monitoring team to provide technical assistance.

Executive Order No. 39, signed by Executive Secretary Lucas Bersamin on August 31, set the price ceiling for regular milled rice at P41 per kilo and P45 per kilo for wellmilled rice. Trade and Industry Secretary Alfredo Pascual had warned that those violating the price ceiling could face penalties of P5,000 to as high as P1 million under the Price Act. He said violators could also face imprisonment for not less than a year or more than ten years.

President Ferdinand Marcos Jr. earlier assured assistance to rice retailers and traders who will be affected by the implementation of EO 39. The President has also directed the Department of Social Welfare and Development, DTI and DA to expedite assistance to small rice retailers affected by the directive.

The President cited the need for government intervention to address the rising rice prices in the market, stressing that illegal activities of rice hoarders, cartels, and smugglers are affecting the economy and the Filipino people. (PIA-4A)

# Rice retailers appeal to traders to lower rice prices

CALAMBA CITY, Laguna (PIA) — Several rice retailers have appealed to rice traders and the government for lower rice prices so they can sell it at prices mandated by Executive Order No. 39.

At the Lucena City Public Market, regular and well-milled rice prices still range from P52 to P55 as rice retailers could not fetch lower-priced rice from their suppliers.

"We will comply if we are able to acquire that kind of rice at such low prices. As retailers, our capital in rice is already high, so how can we sell it at such cheap prices," said Flor Magnaye, a rice retailer at Lucena City Public Market.

She also asked the government to allow them to consume their existing rice stocks to avoid losses from their invested capital.

"We are hoping that (rice supply with cheap-

er prices) will arrive soon... as retailers, it's difficult to explain to people when the news is already out that there is rice priced at P41 to P45 but we haven't received any at that low cost. If we sell at a low price but still suffer a big loss, what will happen to us," Magnaye explained.

Meanwhile, Mercy Natividad, a rice retailer in Bagong Pook Rosario, Batangas, said they are willing to sell even for a minimal profit margin if they can obtain lower-priced rice from the traders.

"(The price ceiling) will bring some positive effects if retailers can get rice at low prices. We just have to make a small profit and still comply with the order," Natividad said.

Lanie Taclino, a rice retailer from Calamba City, Laguna, said that while the mandated price ceiling would benefit consumers, she is concerned about potential losses for retailers.

"We support the President's efforts because it will help consumers. But how can we sell rice at P41 to P45 if the supplier's price is high. We hope that retailers like us can get low-priced rice so that we can sell it at the price set by the Executive Order," she added.
